

Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at June 30, 2018

Houston, TX – July 2, 2018 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of June 30, 2018.

As of June 30, 2018, the Fund’s net assets were \$311 million and its net asset value per share was \$14.13. As of June 30, 2018, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 481% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 347%.

The Fund had 22,034,170 common shares outstanding as of June 30, 2018.

As of June 30, 2018, equity and debt investments were 95% and 5%, respectively, of the Fund's long-term investments of \$430 million. Long-term investments were comprised of Midstream Company (70%), Midstream MLP (24%), Other Energy (1%), and Debt (5%).

The Fund anticipates that the majority of its investments will consist of investments in midstream MLPs and Midstream Companies. See Glossary of Key Terms in the Fund's quarterly reports.
