

## Kayne Anderson Midstream/Energy Fund Provides Unaudited Balance Sheet Information and Announces its Net Asset Value and Asset Coverage Ratios at December 31, 2018

Houston, TX – January 2, 2019 – Kayne Anderson Midstream/Energy Fund, Inc. (the “Fund”) (NYSE: KMF) today provided a summary unaudited statement of assets and liabilities and announced its net asset value and asset coverage ratios under the Investment Company Act of 1940 (the “1940 Act”) as of December 31, 2018.

As of December 31, 2018, the Fund’s net assets were \$522 million and its net asset value per share was \$10.67. As of December 31, 2018, the Fund’s asset coverage ratio under the 1940 Act with respect to senior securities representing indebtedness was 387% and the Fund’s asset coverage ratio under the 1940 Act with respect to total leverage (debt and preferred stock) was 284%.

The Fund had 48,878,499 common shares outstanding as of December 31, 2018.

As of December 31, 2018, equity and debt investments were 98% and 2%, respectively, of the Fund's long-term investments of \$805 million. Long-term investments were comprised of Midstream Company (70%), Midstream MLP (25%), Other Energy (3%), and Debt (2%).

\* On November 27, 2018, Capital Product Partners L.P. ("CPLP") and DSS Holdings L.P. ("DSS"), entered into a definitive agreement pursuant to which CPLP has agreed to spin off its crude and product tanker business into a separate publicly listed company, which will merge with DSS. In connection with this transaction, all of the Fund's CPLP Class B Units are expected to be redeemed for cash at \$9.00 per unit. The transaction is expected to close in the first quarter of 2019.
