- » KYN intends to achieve this objective by investing at least 80% of its total assets in securities of energy infrastructure companies

- » Opportunity for exposure to North American energy infrastructure sector through investments in traditional midstream, natural gas & liquefied natural gas ("LNG") infrastructure, and power infrastructure
- » Energy and power infrastructure companies have growing cash flows, underpinned by long-term contracts and favorable demand trends. The companies operate businesses with strong competitive moats and high barriers to entry

### Exposure to Critical Energy & Power Infrastructure

- » Energy infrastructure is the backbone of the global energy sector providing access to affordable and reliable energy is critical to the global economy
- » Energy and power infrastructure companies are poised to benefit from favorable global demand trends for energy & power. For instance, all sources of energy are needed to satisfy (i) artificial intelligence ("A.I.") power demand growth, (ii) reshoring of manufacturing and industrial activities and (iii) global population and economic growth
- » North American energy and power infrastructure companies are well positioned to benefit from (and capitalize on) U.S. energy exceptionalism and global energy security



These estimates are based on the fund's anticipated earnings and profits. 

Our distributions are treated as a taxable dividend (qualified dividends) to our common stockholders to the extent of our current and accumulated earnings and profits. If the distribution exceeds our current or accumulated earnings and profits, the distribution will be treated as a return of capital to our common stockholders to the extent of each stockholder's basis in our common stock, and then the amount of a distribution in excess of such stockholder's basis would be taxed as capital gain. A portion of our distributions may be paid from sources other than our current and accumulated earnings and profits. Common stockholders will receive a Form 1099-DIV from us.
